

who is legalesign?



Founded in the University of Edinburgh technology incubator in 2012, Legalesign is a high-performance online electronic signature and document management platform offering "Advanced Electronic Signature" under the EU 910/2014 (eIDAS) regulation.

Feature-rich, secure and reliable, the platform is designed with business in mind, and is adaptable and scalable to fit and grow with your operations:

- Multiple signer workflows accommodate a full range of situations;
- Send single or multiple documents, in sequence and/or in bulk;

save time on time-sheets!

With an e-signature solution you can cut out almost all of the day to day administration associated with time-sheet management.

Legalesign has a time-sheet facility that can be embedded into your website or portal.



e-signature for business

- Employees arrive at your website and navigate to the time-sheet page where they fill in their hours and sign. Totals are automatically calculated.
- If necessary, the time-sheet can be "sent on" by the employee to a third party, manager or your client for a second signature or approval.
- An email notifies you when a time-sheet has been completed and is ready to download.
- All information (e.g. hours) can be exported to a spreadsheet.



candidate registration

The use of e-signature with online forms can revolutionise the candidate registration process.

Over 50% of the documents on the Legalesign platform are signed within two hours.



- Candidates review and sign their documents electronically on mobile, tablet or laptop;
- Recruiters use live tracking functions to follow progress and help candidates with any matters which may be holding them up;
- Form-field validation reduces candidate error; and
- Visiting and signing events trigger email notifications and live updates so that recruiters can respond swiftly and complete.



how secure is e-signature?



Security is a priority across our business and throughout the Legalesign infrastructure.

How can I be sure that changes or amendments are not made to a document?

With e-signature, and especially with LTV (long term validation) you can be confident that the integrity of the document has been maintained throughout the document signing process and after.

Can you be confident that someone has not tampered with a document once it has been signed?

Yes. If any change is made to a document, the digital certificate on that copy will be broken and this will be indicated on the face of the PDF.

Might the certification expire?

Some certificates expire after a few years. With long term validation, the validity of that certification is contained within the document and date stamped so that at any time in the future, authentication at the time of signing can be evidenced; re-certification by Legalesign is not required.

Is my data secure?

Legalesign uses secure data facilities that meet ISO9001 and ISO27001 standards. Legalesign is ISO27001 certified for information security for electronic signature and document management.



EU law and the Advanced Electronic Signature

Also known as 'eIDAS', EU Regulation 910/2014 became legally binding on 1st July 2016. The eIDAS regulation sets the standards for electronic transactions across the EU.

Legalesign offers the 'Advanced Electronic Signature' as set out in Article 26 of the regulation. An Advanced Electronic Signature meets the following requirements:

- It is uniquely linked to the signatory;
- It is capable of identifying the signatory;
- It is created using electronic signature creation data that the signatory can, with a high level of confidence, use under his sole control; and
- It is linked to the data signed therewith in such a way that any subsequent change in the data is detectable.

how do we comply?

- Legalesign's software sends a "one use" document link to the signatory via an email. Use of an additional secret code is optional;
- The signatory is uniquely identified by the email as well as by their signature itself;
- The signing interface is easy to use and the signing process is exclusively accessible to the signer; and
- The final PDF, which contains a full audit log of events, date stamps and IP addresses, is certified (with long term validation) and contains a tamper-proof code that will break if any subsequent change is made to the document or the data it contains.

ACKERMAN PIERCE

THE COMPANY

Ackerman Pierce is a nationwide highly respected recruitment company specialising in social care. Their reputation has gone from strength to strength because of their dedication to developing the optimal candidate registration process and at the same time ensuring that all agents have detailed knowledge of their specific fields. BEFORE LEGALESIGN

In recruitment, a good candidate is gold dust and a recruitment company must do everything it can to keep a candidate from going elsewhere and to make sure he or she is available for employment as soon as possible. That means getting candidate registration complete in one go and on the first visit. The amount of information needed for a candidate registration is extensive and requires a 15 page long pack for the candidate to complete. These packs were emailed to the candidates who needed to print, sign and scan them. This meant whenever a pack was incomplete or incorrectly completed it would need to be sent out again, printed again, scanned again. This led to frustration on the part of the candidate and resulted in long delays and lost candidates.

BEFORE LEGALESIGN
